# TruScreen Group Limited (ASX: TRU) – Admission and commencement of Official Quotation – Foreign Exempt Listing

#### **Description**

TRU raised NZ\$2,000,000 pursuant to the offer under its product disclosure statement dated 10 November 2020 ('PDS') by the issue of 28,571,428 shares at an issue price of NZ\$0.07 per share.
